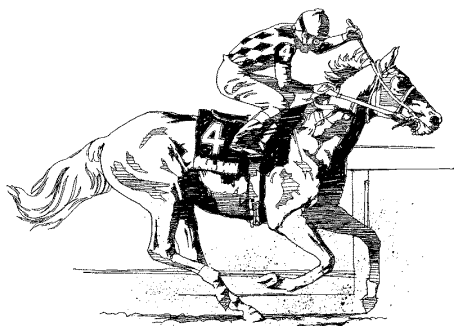


## HOW CAN YOU HELP SAVE ELLIS PARK?
