(1) A current negative Coggins Test dated less than one year prior to date of arrival, and listed on a Certificate of Veterinary Inspection (CVI), which has been signed and dated within seventy two (72) hours prior to arrival by a licensed veterinarian.

(2) A vaccination against Equine Herpes Virus Type 1 (EHV-1) by a licensed veterinarian a minimum of fourteen (14) days, and no more than one hundred twenty (120) days of entry into our stable area(s). The Certificate of Veterinary Inspection (CVI) shall indicate the date of the vaccination, the specific vaccine product, vaccine lot number, and vaccine expiration date, used to vaccinate each horse.

Horses shipped to Ellis Park without approval will not be unloaded. The Rules adopted by the Kentucky Horse Racing Commission govern all races over the course of Ellis Park.
